

5002 is used to control bacteria and fungi in recirculating commercial and industrial air conditioning systems. In its use, systems must be cleaned to remove slime, and other deposits. An initial slug addition of 11.1 fluid ounces of 5002

per 1000 gallons of water to provide a concentration of 24 ppm, is recommended. Repeat initial slug additions of 0.73 5002 per 1000

parts per million of 5002

employed every 2 to 5 days, or as needed. The frequency of addition depends upon the relative amount of bleedoff and the severity of the bacterial problem. Slug additions should be made in the summer months. An initial slug dose of 11.1 5002 is used

for air-washing systems that maintain effective minimum relative humidity. In its use, systems should be cleaned to remove deposits. An initial slug dose of 11.1 5002 per

1000 gallons of water should be employed every 2 to 5 days, or as needed. The frequency of addition depends upon the relative amount of bleedoff and the severity of the bacterial problem. Slug additions may be made in the summer months. An initial slug dose of 11.1 5002 is used for collection trays of the airwash system.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

STORAGE: Do not stack more than four drums high. Leaking drums should be placed on a secondary containment container for disposal. Spills should be absorbed in sawdust or sand and the container closed when not in use.
