

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

WATERCIDE - Q is used to control bacteria, algae, and fungi in recirculating commercial and industrial cooling systems. To its use, systems must be cleaned to remove scale, slime, and other deposits. An initial slug addition of WATERCIDE - Q fluid ounces of WATERCIDE - Q per 1000 gallons of water to provide a concentration of 48 to WATERCIDE - Q, based on the system, is recommended. Repeat initial dosage of 1.53 to WATERCIDE - Q per 1000 gallons of water to provide a concentration of 120 parts per million of WATERCIDE - Q employed every 2 to 5 days, or as needed. The frequency of addition depends upon the relative amount of bleedoff and the severity of the bacterial problem. Slug additions should be made in the sump or collection trays of the airwash system. WATERCIDE - Q is used to clean air-washing systems that maintain effective mist levels. To its use, systems should be cleaned to remove scale, slime, and other deposits. An initial slug dose of 24.7 to WATERCIDE - Q per 1000 gallons of water should be employed each 2 to 5 days, or as needed. Repeat initial dosage until control is evident. Subsequent slug additions of 16.9 to 41.2 fluid ounces of WATERCIDE - Q per 1000 gallons of water should be employed each 2 to 5 days, or as needed.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.
STORAGE: Do not stack more than four drums high. Leaking or damaged drums for disposal. Spills should be absorbed in sawdust or sand and container closed when not in use.
PESTICIDE DISPOSAL: Wastes resulting from the use of this product should be disposed of by approved waste disposal facility.
