- d. Delete the footnote "* by AOAC Method of Analysis (9th Ed.)".
- e. Delete the statement: "Flashpoint (169°F)"
- f. Revise the second paragraph of the Directions for Use to read as follows:
 For Formulation of Pesticide Products Only
 Mix well in drum before sampling and each use.
 Technical information of the use of this product is available from CIG Pyrethrum.
- g. Revise the first sentence of the Environmental Hazards to read as follows:

 This pesticide is toxic to fish and other aquatic animals.
- Revise the Pesticide Disposal Statement to read as follows:
 Wastes resulting from use of this product may be disposed of on site or at an approved waste disposal facility.
- i. Reference is made on the label to the availability of technical information on the use of this product. You must submit for the record a copy of this technical information.
- 3. Submit a Confidential Statement of Formula (CSF) revised so that the Certified Limits for the pyrethrins active ingredient bracket its nominal concentration (label claim) of 20%.
- 4. The CSF lists the density as 7.04 lb./gal. However, the information submitted as part of the product chemistry states that the density is 0.973 g/ml or 8.13 lb./gal. You must fix this discrepancy, and, if necessary, correct item 7 in the CSF.
- 5. Submit two copies of the revised final printed label for the record.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

A stamped copy of the label is enclosed for your records.
