To facilitate inclusion of required language from the DEET Reregistration Eligibility Decision (RED), replace paragraph 1 with: "For best results, spread evenly and completely over all exposed skin. **DO NOT** apply over cuts, wounds or irritated skin. Apply to palm of hand for application to face and neck and rub on. **DO NOT** apply near eyes and mouth, and apply sparingly around ears. Use just enough repellent to cover exposed skin. General Comment(s):

9. The marketing statement on page 2 of 2 that reads "Controlled release formula ..." should be revised to read: "Controlled release formula allows 34.34% DEET to repel mosquitoes up to 12 hours."
10. Delete the table on page 2 of 2 of the label which compares Product, Hours of Protection and DEET Levels since comparison claims are not permitted.



When the guidelines are finalized, the Agency expects to issue a Data Call-In to address the revised guidelines to all registrants with registrations for personal repellent products that have not previously submitted efficacy data sufficiently consistent with the revised guidelines.

A copy of your label stamped "Accepted with Comments" is enclosed for your records. Please submit two (2) copies of the final printed labeling, incorporating the above changes, before releasing the product for shipment. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing amended labeling constitutes accepting of these conditions.
