1. Relocate the 9<sup>th</sup> optional marketing statement "Time Release Technology developed by 3M for the U.S. Military" to the back panel of this label. As stated in an SAL for this product dated December 14, 2004, this statement cannot not be used in conjunction with any marketing claims (either directly, or indirectly (i.e., footnoting)). In addition, this relocated statement must maintain the same font size, color, background and text orientation as the smallest font size on the back panel. The preferred location for this statement is outside of the Directions for Use section, either directly above or below the company name and address.


2. Revise the line labeled as "**If empty:**" to read "**If Empty:** Non-refillable container. Do not reuse or refill this container. Offer for recycling, if available."
