Temporary Pools of Standing Water: Apply ReJeX-ITTM AP-60 at a rate of 170 lbs AP-50 per acre (85 lbs a.i. per acre) of water surface when depth < 1 linch, at 3-4 week intervals. Adjust timing of subsequent applications as required by bird activity and anticipated seasonal migrations. For pools of water 2-3 linches deep, aprily ReJcX-ITTM 4.9 50 at a rate cf-340 514 lbs AP-50 per acre (1.70-257 lbs a.i. per acre) of water surface. Do not add additional product if there is no bird activity.

Landfills: Mix 50-150 lbs (25-75 lbs a.i.) of ReJeX-iT[™] AP-60 with each 500 gal of landfill cover spray (such as DayControl[®] or ConCover[®] from New Waste Concepts, Inc.) (5. Jach 5,000 sqft of working face per day.
