5. Follow the instructions, including minimum type sizes, on the A-79 Enclosure.

2. Acute Freshwater Fish LC-50 (154-8)

Talking ponds, impoundments (non fish bearing bodies of water): Apply ReJeX-iT™ TP-40 at a rate of 20 lbs per acre (8 lbs a.i. per acre) of water surface at 3-4 week intervals. Adjust timing of subsequent applications as required by bird activity and anticipated seasonal migrations. Best applied by spray equipment directly without any further dilution.

Landfills: Apply ReJeX-iT™ TP-40 at a rate of 20 lbs per acre (8 lbs a.i. per acre) directly to the active face as soon as the birds start to arrive. Repeat application as long as birds persist.
