Becker Underwood, Inc. is notifying the Agency that we are correcting a typographic error in our February 1, 2001 Rejex-it<sup>®</sup> AG-36 (EPA Reg. No. 58035-9) notification. Specifically, we are correcting the last sentence in the small area dilution directions to now read "mix 8 ounces of product with 96 oz. (3 qts.) of water to made 104 oz. **of spray mixture.**"

This notification is consistent with the provisions of PR Notice 98-10 and EPA regulations at 40 CFR Part 152.46, and no other changes have been made to the labeling or the confidential statement of formula of this product. I understand that it is violation of 18 USC Section 1001 to willfully make any false statement to EPA. I further understand that if this notification is not consistent with the terms of PR Notice 98-10 and 40 CFR Part 152.46, this product may be in violation of FIFRA and I may be subject to enforcement action and penalties under sections 12 and 14 of FIFRA.

- Small area (i.e., application by hand or backpack sprayers): Mix Rejex-it® AG-36 with water at a ratio of 1 part product to 12 parts water. For example, mix 8 ounces of product with 96 oz. (3 qts.) of water to make 104 oz. of spray mixture.
- Large areas (i.e., application by boom sprayers): Mix Rejex-it® AG-36 with water at a ratio of 1 part product to 20 parts water. For example, mix 2.5 gallons of product with 50 gallons of water to make 52.5 gallons of spray mixture.

**APPLICATION DIRECTIONS:**

- Small area (i.e., application by hand or backpack sprayers): Apply at a rate of 104 oz. spray mixture (0.07 lbs a.i.) per 1000 square feet of turf.
- Large areas (i.e., application by boom sprayers): Apply at a rate of 52.5 gallons of spray mixture (3.07 lbs a.i.) per acre of turf.

Spray evenly on area to be protected to provide thorough coverage and allow material to dry before permitting human activity on the treated area. Repeat application in 4 days or as warranted by Canada goose activity. Do not mow treated area for several days after application.
