

KOBAN 30 is intended for use on ornamental turf which is subject to Pythium blight, damping off, cottony blight and Pythium Root and Crown Rot. It may be used at time of seeding to control damping off, or on establishing turf to prevent or control Pythium blight (cottony blight and Pythium Root and Crown Rot).

KOBAN 30 does not afford broad spectrum fungus disease control for Rhizoctonia (brown patch). Sclerotinia (dollar spot), Gloeocercospora (copper spot), and similar turl diseases. A fungicide program to control these diseases should be followed if they co-exist with Pythium blight. 5-6 oz. in 5 gal. water per 1000 sq. ft. Drench (Irrigate) the treated area immediately following application to increase performance. During periods of high daytime temperatures (90°-95°F.), apply KOBAN 30 in early morning or late afternoon.

Apply uniformly to the turf area with a SPRAY-HAWK $^{\bullet}$ mobile spray boom or other suitable equipment.

Re-treat in 5 to 10 days, depending upon climatic conditions, to maintain disease control. KOBAN 30 should not be mixed with other pesticides or nutrients.

For control of damping-off in newly seeded areas: Apply 7 to 9 oz. of KOBAN 30 in 5 to 10 gal. cf water/1000 sq. ft. immediately after seeding. Irrigate promptly for improved soil penetration of the fungicide and to initiate seed germination. Retreat at 5 to 7 day intervals at the 2 to 4½ oz. rate in order to maintain a preventive disease control program after germination.

Use FUNGO® 50, DUOSAN® or VORLAN" to control a broad spectrum of diseases other than Pythium.

Grass Seed Treatment: To prevent Pythium blight add 4½ to 7 oz, of KOBAN 30 to the seed treater for each 100 lb. of grass seed. Blend until the KOBAN 30 is thoroughly dispersed in the seed.

NOTE: For smaller seeds use the higher rate of KOBAN 30.

IMPORTANT: Bags containing treated seed should bear a tag with the following statement. This seed has been treated with 30% Ethazole at the rate of 4½ to 7 oz./100 lb./seed. DO NOT USE FOR FEED, FOOD, OR OIL PURPOSES.

STORAGE AND DISPOSAL

STORAGE: Not sensitive to light. Stable at normal temperatures and humidities. Store in a dry place at temperature above 45°F. (7°C.), in a well-closed container.

PROHIBITIONS: Do not contaminate water, food, or feed by storage or disposal. Open dumping is prohibited

PESTICIDE DISPOSAL: Pesticide, spray muture or rinse water that cannot be used according to label instructions must be disposed of according to applicable Federal, State or local procedures.

CONTAINER DISPOSAL: Completely empty bag by shaking and tapping sides and bottom to loosen clinging particles. Empty residue into application equipment. Then dispose of bags in a sarvary landfill or by incineration if allowed by State and local authorities.


