RE: Notification of General Labeling Revisions EPA Registration Number: 58185-8 Date of Submission: April 21, 2009

Dear Ms. Newell:

This letter rescinds our letter dated July 30, 2009, for the above notification. RD has reevalauted the warranty statement and has determined that it falls within the scope of PR Notice 98-20 and found acceptable . Please note that RD has determined that the following issues will need to be address in your next submission. Below is a summary of the findings.

- 1. The first sentence under the heading for **Conditions** should be removed.
- 2. The choice of words in the first sentence under **Warranty** should be rephrased. It is somewhat confusing.
- In the second paragraph under the heading for Disclaimer and Limitation of Liability, remove the phase "By using this product" and replace with "To the extent consistent with applicable law, user or buyer accepts the conditions, ..." The Agency has indicated to other companies that they cannot have a limitation on the label that we would not be able to enforce under FIFRA.
- 4. Regarding the last sentence under the heading Limitation of Liability, EPA cannot under FIFRA enforce companies to have any limitations. We would therefore suggest you consider language about providing prompt notice that avails Scotts the opportunity to investigate the claims.

Please find attached an Application of Registration for notification of general labeling revisions for the above referenced product registration. Included with this cover letter are the following:

- Two, "clean" copies of updated Master Label
- Copy of 9/28/2007 Master Label for reference purposes only

Alternate Brand Name for this product is now noted on Master Label: Truban® 25 EC

General labeling revisions are as follows:

- Pages 1 & 9: Per P.R. Notice 2001-5, Resistance Management mode of action language for Group 14 Fungicide has been added.
- Page 1: Replaced "Distributed by" with "Manufactured for/by."
- Page 1: Added copyright and trademark statements.
- Page 2: Updated phone number within "First Aid" section.
- Pages 5-7: The "Chemigation Information" was presented as supplemental labeling on the 9/28/07 Master Label. This section has been moved and is now included as part of the label. Within this 3 section, "Sprinkler Chemigation" has been updated as requested and/or approved by the Agency on other more recent labels, including 58185-33 and 58185-7.
- Page 7: In second paragraph under "Ornamentals and Nursery Crops," we have deleted the reference to mixing "into the growing medium" as there are no directions included for this use. The sentence now includes only drench reference: "Truban® Fungicide 25% Emulsificable Concentrate, ... may be used at time of seeding and transplanting as a drench..."

- Page 7: In third paragraph under "Ornamentals and Nursery Crops," corrected wording to read: "... should be *occasionally* agitated" instead of "*constantly* agitated." This now aligns with instructions located elsewhere on the label.
- Page 7 & 8:

**Background**: There is a section at the end of the 9/28/07 Master Label (pages 12 & 13) following the Chemigation Section titled, "General Information." This section is not part of the Chemigation Section, and was evidently "cut and pasted" from another label by us into this label during the RED process. Most of the section does not belong on the label; however, there are two parts of this section that do pertain to this product and have been moved as indicated below. The two remaining paragraphs under this section were never used on any printed labeling and have been deleted. (1) The statement "Do not apply when wind speed favors drift beyond the area intended for treatment." has been moved to Page 7 on the attached revised Master Label. (2) Also moved was the paragraph starting with "IMPORTANT: If, after using Truban 25%

Emulsifiable Concentrate as recommended, treatment is not effective, a tolerant strain of fungus may be present. ..." This paragraph has been moved to Page 8 of current label right before the "Resistance Management" section.

- Page 8: Corrected "Plant Types" listed to match earlier approved labeling.
- Page 9-10: Updated warranty which has been approved by the Agency on other more recent labels, including 58185-7.



TRUBAN FUNGICIDE 25% Emulsifiable Concentrate suspensions in water should be occasionally agitated to assure uniform mixing and application. TRUBAN FUNGICIDE 25% Emulsifiable Concentrate suspensions need not be protected from light. Use at specified rates and concentrations. Overdosage may result in toxicity to sensitive plants. If plants are suspect of being sensitive, apply fungicide to a small number to insure safety. TRUBAN FUNGICIDE 25% Emulsifiable Concentrate should not be mixed with the safety.
