ALFA-SAVE SPECIAL is appropriate for use on forage crops (Alfalfa, Bermuda grass, Bluegrass, Brome grass, Clover, Fescue, Lespedeza, Lupines, Orchard grass, Peanut hay, Peavine, Rye grass, Soybean hay, Timothy, Vetch) preserved as hay, whether in conventional baling systems, stackers, large round or square balers. ALFA-SAVE SPECIAL is also appropriate for addition to stored grains (Barley, Corn, Oat, Sorghum, Wheat).

Product effectiveness depends on method of application and treatment rate. As moisture level determines treatment rates, ensure that hay moisture level is known. FOLLOW RECOMMENDED RATES WITHIN EACH MOISTURE RANGE! When usage rate recommendations are followed, ALFA-SAVE SPECIAL will protect hay through the curing/drying process when adequately protected from weather.

APPLICATION:

Uniform distribution is very important. The hay should be raked into medium-sized, fluffy windrows. A 3-nozzle boom should be attached to the baler pick-up such that hay is sprayed while still fluffy so the spray can penetrate the windrow. Fan-type nozzles should be used with a minimum pressure of 20 lbs. per square inch. Flood type nozzles are not satisfactory.
