Do not spray directly on face. Do not apply over cuts, wounds, or irritated skin. Repeat as needed. For ticks and chiggers, also apply liberally to shoe tops, socks, and around openings in clothing. After returning indoors, wash treated skin with soap and water. Wash treated clothing. Use of this product may cause skin reactions in rare cases. If you suspect that you or your child is reacting to this product, wash treated skin and call your local poison control center.
