#### DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

<u>SPACE SPRAY to Kill Flies, Gnats and Mosquitoes</u>: Direct spray upwards towards upper corners of structure being treated. Close all doors and windows and keep closed for 10-15 minutes. Ventilate prior to reentry. Sweep up and destroy fallen insects.

To Protect Dairy Cows and Cattle from Gnats, Horn Flies, Horse Flies, Houseflies, Mosquitoes, and Stable Flies: Animals should be sprayed Gaily before the morning or evening milking. Apply as a light mist from a distance of two feet, permitting the spray particles to collect upon the hair coat. Special attention should be given to shoulder blades, stomach and legs. Do not soak the hide. Wash udder and teats with soap and warm water prior to milking.

For Calves and Other Livestock such as Horses and Swine: Spray very lightly once or twice daily.

To Protect Cattle and Other Livestock from Attack by Fleas, Lice and Ticks: Spray bedding and walls of pen, particularly cracks and crevices. Livestock should be lightly sprayed and the spray immediately rubbed into the hair, paying particular attention to infested areas. Ticks must be contacted directly with the spray. Repeat as necessary.

To Protect Cattle and Other Livestock from Attack by Face Flies: Apply spray to a heavy cloth or sponge and wipe on face and around ears of livestock, paying particular attention to areas around eyes and nostrils. Avoid getting material in animal's eyes. Treatment should be made daily while the cattle

are stationed for the morning milking to give protection from face flies.

### STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

STORAGE: Store in a cool, dry place inaccessible to children. Keep container closed.

<u>DISPOSAL</u>: Replace cap and discard container in

trash. Do not incinerate or puncture.
