On the basis of information furnished by the registrant, the above named pesticide is hereby Registered/Reregistered under the Federal Insecticide, Fungicide, and Rodenticide Act.

A copy of the labeling accepted in connection with this Registration/Reregistration is returned herewith.

In order to protect health and the environment, the Administrator, on his motion, may at any time suspend or cancel the registration of a pesticide in accordance with the Act. The acceptance of any name in connection with the registration of a product under this Act is not to be construed as giving the registrant a right to exclusive use of the name or to its use if it has been covered by others.

This product is conditionally registered in accordance with FIFRA Sec. (c)(1)(3) provided that you:

1. Submit and/or file all data required for registration/reregistration of your product under FIFRA Sec. (f)(1) when the Agency requires all registrants of similar products to submit such data.

2. Make all labeling changes first as follows before you release the product for sale:

a. Add the phrase, "EPA Registration No. 58300-2."

b. The composition of your product does not indicate an acute non-chronic hazard if the product was ingested and vomiting was induced. If your toxicological data suggests otherwise, you must submit a draft statement. If not, revise the IF Swallowed statement as follows:

IF Swallowed - Call a physician or Poison Control immediately. Drink one or two glasses of water and induce vomiting by touching the back of throat with a finger. Do not induce vomiting or give anything by mouth to an unconscious or convulsing person.

- c. Delete the paragraph beginning "This is specially processed Diatomaceous Earth fossil product and is ...". Words or phrases implying that a product possesses unique characteristics because of its composition are not acceptable. In addition the statement is misleading since this is not a diatomaceous earth product, but a product composed of diatomaceous earth, piperonyl butoxide and pyrethrin.
- d. As currently written the sites of application and pests controlled are lumped together. For the layperson more specific directions regarding where to apply the product to control specific pests should be given. We suggest you revise the directions similar to that appearing on the label under EPA Registration No. 6330-1, i.e.,

For roaches and silverfish: Dust lightly paying special attention to cracks and hidden surfaces around pipes...etc.
Ants, crickets, boxelders bugs: Dust lightly areas around windows...etc.

3. The additional products labels submitted with you May 8, 1990 letter are being returned. They must be resubmitted as application for new registration since the directions for use and precautionary statements are different then the subject product label. Note also that the ingredient statement "Multipurpose Contact Insecticide" is different than the subject product formulation.
4. Submit five (5) copies of your final printed labeling before you release the product for shipment. Refer to the A-79 Enclosure for a further description of final printed labeling.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

A stamped copy of the label is enclosed for your records.

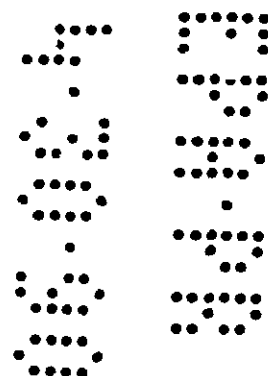
