On the basis of information furnished by the registrant, the above named pesticide is hereby registered/reregistered under the Federal Insecticide, Fungicide and Rodenticide Act.

Registration is in no way to be construed as an endorsement or recommendation of this product by the Agency. In order to protect health and the environment, the Administrator, on his motion, may at any time suspend or cancel the registration of a pesticide in accordance with the Act. The acceptance of any name in connection with the registration of a product under this Act is not to be construed as giving the registrant a right to exclusive use of the name or to its use if it has been covered by others.

This product is conditionally registered in accordance with FIFRA sec. 3(c)(7)(A) provided that you:

1. Submit and/or cite all data required for registration/reregistration of your product under FIFRA sec. 3(c)(5) when the Agency requires all registrants of similar products to submit such data; and submit acceptable responses required for reregistration of your product under FIFRA section 4.

2. Make the following label changes:

- a. Revise the EPA Registration Number to read, "EPA Reg. No. 58369-3".
- b. The label claim "Insecticidal Shampoo & Repellent for Pets instantly kills. . . eggs and larvae" must be modified to depict "mites" as the last pest so that it is evident that ". . . embedded eggs and larvae" applies only to mites.
- c. Delete all references to use on puppies and kittens and incorporate the following directive on your label: "FOR USE ON ADULT DOGS AND CATS ONLY. DO NOT USE ON PUPPIES AND KITTENS."
- d. Delete all references to "non-toxic" and "non-poisonous" on the label.

- e. Delete all statements regarding use on "skin sensitive" animals and on pregnant and nursing bitches. All other references to a soothing effect of the product should also be deleted (refer to Agency's Domestic Animal Safety review of January 24, 1994 for specific rationale).
- f. The label must bear the following headings and precautionary statements:

**PRECAUTIONARY STATEMENTS
Hazards to Humans and Domestic Animals**

CAUTION

Harmful if absorbed through skin. Avoid prolonged contact with skin, eyes, or clothing. Wash thoroughly with soap and water after handling. Prolonged or frequently repeated skin contact may cause allergic reactions in some individuals.

- g. The child hazard warning statement must appear on the front panel of the label as follows: **KEEP OUT OF REACH OF CHILDREN.** The signal word **CAUTION** must also appear on the front panel of the label.

3. Submit two copies of the revised final printed label for the record.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

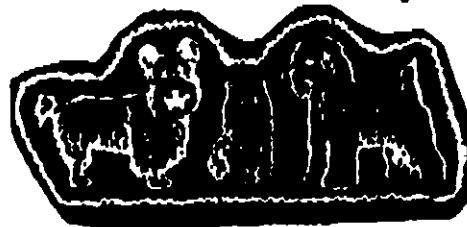
