


WEEDEX DANDELION STICK® is a ready-to-use weed killer which controls many broad-leaf weeds in lawns and other areas such as dandelions, plantains, clover, henbit, oxalis, spurge, wild violet and ground ivy.

DIRECTIONS FOR USE:

Avoid contact with eyes, skin, or clothing during application and after application. Do not apply this product in a way that will contact any person or pet. Keep people and pets out of the area during application.

- For best performance, WEEDEX DANDELION STICK® should be at least 70°F before use.
- Unscrew plastic protective cap (arrow at bottom of cap indication direction). Apply WEEDEX DANDELION STICK® (herbicidal wax) directly to stems and leaves of weed with a twisting and/or turning action.
- ***Note*** Use light pressure. It is not necessary to leave a visible wax coating on weed leaves for the product to perform.
- After use, replace (screw on) protective cap.

When To Use: WEEDEX DANDELION STICK® may be used anytime when weeds are actively growing, preferably a day or two after mowing (cutting grass) when temperatures are above 70°F.

What To Look For After Treatment: Twisted weed growth and discoloration should start to appear in about 7 to 10 days. Weeds such as ground ivy may take 4 to 6 weeks to die.

Use Precautions: Do not touch WEEDEX DANDELION STICK® to flowers, shrubs, or other desirable plants. Grasses should not be injured when the WEEDEX DANDELION STICK® is used as directed.
