You must submit one (1) copy of the final printed labeling before you release this product for shipment with the new labeling. In accordance with 40 CFR § 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR § 152.3.

Should you wish to add/retain a reference to your company's website on your label, then please be aware that the website becomes labeling under FIFRA and is subject to review by the U.S. Environmental Protection Agency (EPA). If the website is false or misleading, the product will be considered to be misbranded and sale or distribution of the product is unlawful under FIFRA section 12(a)(1)(E). 40 CFR § 156.10(a)(5) lists examples of statements the EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration

TOBACCO (FLUE-CURED): Use 2 quarts immediately after filling 1,500 to 2,500 cubic feet curing barn over a period of 12 to 24 hours. Use additional 2 quarts as required.

Do not use any other ethylene equipment or products when using Ripener I Concentrate and ARCO Ethylene Generator. Use of this product in enclosures less than 1,500 cubic feet is prohibited. The treated room should be reasonably airtight, all vents and doors closed, cracks or holes in walls and doors should be repaired or covered.
