To repel rattlesnakes (Genus Crotalus) and checkered garter snakes (Thamnophis marcianus) from areas around houses, cabins, trailers, garages, utility houses, barns, woodpiles, sand piles, trash cans, and flower beds. This product may also be used around the periphery of gardens. Do not use this product at sites where snakes are believed to be already present as the deterrent effects of the product might tend to confine snakes to the treated areas.

Use in spring, summer, and fall when you expect temperatures to promote unwanted snake activity in the target areas:

Do not apply this product in gardens or in fields of crops grown for food or feed. Do not use this product near suremy, ponds pools, or water supplies.

Tests of this product have suggested that it can be an effective deterrent for the types of snakes listed above. While the product might deter other types of snakes as well, it is not expected to consistently repel snakes of the following types: corn snakes and other rat snakes (Genus Elaphe); and "moccasin" snakes such as cottonmouths and copperheads (Genus Agkistrodon).

APPLICATION DIRECTIONS: Using gloves, apply SNAKE-A-WAY IN BANDS SURRONDING THE AREA TO BE PROTECTED. Use bands 4 to 5 inches wide to repel checkered garden snakes. For rattlesnakes, use bands 8 to 12 inches wide. In yards, lightly sprinkle Snake-A-Way over the area within the treatment band.

When the odor of Snake-A-Way becomes faint, its effectiveness may be diminished. If this occurs during the season when snakes are active, retreat with enough of the product to restore the original odor intensity. Retreatment may also be necessary after heavy rains.

RATS AND MICE:

<u>USE RESTRICTIONS:</u> FOR OUTDOOR USE ONLY. APPLY ONLY AS DIRECTED ON LABEL. This product may be used to limit damage by house mice (<u>Mus musculus</u>), Norway rats (<u>Rattus norvegicus</u>), or roof rats (<u>R. rattus</u>) to garbage bags placed near residences and other buildings or to garbage bags placed along streets or alleys for garbage collection.

Do not use this product in gardens or in fields of crops grown for food or feed. Do not use this product near streams, ponds pools, or water supplies, or sewers.

APPLICATION DIRECTIONS: Using gloves, apply in a lightly sprinkled band around the area where garbage bags are placed. Beginning no more than one foot out from the outermost bags, lightly broadcast until band of product is 24 inches wide. When the odor becomes faint, its effectiveness may be diminished. Retreatment may also be necessary after heavy, washing-type rains.

STORAGE & DISPOSAL: [Homeowner Sizes]

STORAGE: Store only in original container, in a cool, dry, and well-ventilated location inaccessible to children, and pets. **DISPOSAL:** If Empty: Do not reuse this container. Place in trash or offer for recycling if available.
