

While the product might deter other types of snakes as well, it is not expected to consistently repel snakes of the following types: corn snakes and other rat snakes (Genus <u>Elaphe</u>); and "moccasin" snakes such as cottonmouths and copperheads (Genus <u>Agkistrodon</u>).

**APPLICATION DIRECTIONS:** Using gloves, apply SNAKE-A-WAY IN BANDS SURRONDING THE AREA TO BE PROTECTED. Use bands 4 to 5 inches wide to repel checkered garden snakes. For rattlesnakes, use bands 8 to 12 inches wide. In yards, lightly sprinkle Snake-A-Way over the area within the treatment band.
