Attach one tag per animal in the spring to control horn flies for that summer season. Tags are easy to apply or replace as necessary. Attach two tags per animal to control face flies, gulf coast ticks, spinose ear ticks and as an aid in the control of lice, stable-flies and houseflies.

INSECTICIDAL EAR TAGS are easy to attach using a variety of methods. They may be punched through an existing ear tag using the Fearing tagging system. However, tags punched through adult sized identification tags on young calves may result in tearing the ear and loss of the tags. Tags may also be positioned across entryways where animals are forced to use them as they gain access to barns, feeders, waterers or milking areas.

Calves and cows may mutilate tags by sucking and chewing. Effect-iveness against ectroparasites may be reduced.

## STORAGE AND DISPOSAL

STORAGE: Do not contaminate water, food, or feed by storage or disposal. Remove tags before slaughter. Keep container sealed when not in use.
