Form about one ounce lumps of paste with a knife or spatule and spread to about one-half inch thickness behind and under stationary floor appliances and furniture (including stoves, refrigerators, freezers, sinks, utility and work tables, ice and drink machines, and booths). ALSO: One ounce lumps can be spread on metal or plastic trays and placed under stationary furniture and appliances. Reapply if necessary.
