NON-BEARING NUT, CITRUS AND PEACH TREE WRAPS: (Trees wrapped for frost and sunscald protection which are not expected to bear fruit for 12 months following the last application of PEST STOPPER PACK.)

Place one sachet in each tree wrap to control ants, including fire ants, and crickets. Replace after six (6) months.
