DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Do Not Use On Dogs Under 12 Weeks. Wet the animal's coat with warm water. Work the shampoo into the coat starting with the head and ending with the tail. Keep shampoo away from the eyes. Allow lather to remain for 5 minutes. Rinse thoroughly and towel dry. Do not repeat treatment for 3 days.

PRECAUTIONARY STATEMENTS: HAZARD TO HUMANS AND DOMESTIC ANIMALS.

CAUTION: Causes eye irritation. Do not get in eyes. In case of contact, immediately flush eyes with plenty of water. Get medical attention if irritation persists.
