The signal word "CAUTION" and "Keep out of Reach of Children" needs to be moved onto the front panel.

As new labels are prepared, please change the active ingredient percentage to include related compounds. The label should read:

20pt) CAUTION

Do not use indoors. Cover exposed food. Avoid prolonged inhalation. Do not touch lit end. Do not place on flammable surfaces.

Store in original container. Do not reuse container. Securely wrap container in several layers of newspaper and discad in trash can.

For best results use in a confined area with little or no breeze. Place one coil every 8 to 10 feet on patios, cabanas and campsites.

DIRECTIONS FOR USE

- It is a violation of Federal law to use this product in a manner inconsistant with its labeling.
- 1. Carefully separate both coils. Do not force them apart as they may break.
- 2. Unfold the provided metal stand
- 3. Place center-most opening in coil onto lip of metal stand. Light outer tip of coil with a match or cigarette lighter. As the coil begins to burn, blow out the flame. The smol ering tip will release a thin fume that will repel mosquitoes for over 5 hours, at which time the entire coil will have been reduced to a white ash.
- 4. For shorter protection times, segments of the coil maybe broken off and inserted into the stand. Iqnite as above.
