Based on your response to the Reregistration Eligibility Document(s), EPA has reregistered the product listed above provided that the following change is made to the label:

Currently there are no source suppliers for Orthoboric Acid that are supporting the
application of borates to furniture fabric, mattresses, box springs, pillows, or sheets or
filters in home heating/air conditioning systems. Therefore, delete the following
associated text from the label:

"Additional Use sites and Application Instructions: Remove loose cushions of upholstered furniture. Apply powder along creases and into corners and furniture wells. Do not apply product to exposed fabric. Work powder deep into wells and the surrounding hidden furniture fabric until it disappears. Apply powder lightly to all mattress, box spring, cushion and pillow surfaces that will be covered with sheets or like fabric after treatment. Any powder visible after application must be removed."

After applying to filters remove any non-adhering powder by gently tapping filter on edge against a hard surface. Remove any product that becomes dislodged by vacuuming."

- 2. Revise all verbiage identified as "apply liberally" to "apply sparingly"
- 3. Revise all application intervals identified as "Reapply as necessary" to "Reapply after 30 days if necessary."
- 4. Revise the header "DOMESTIC (HOMEOWNER USE) FLEAS" to "FOR RESIDENTIAL USE TO CONTROL FLEAS AND DUST MITES", and "DOMESTIC (HOMEOWNER USE) COCKROACHES, ANTS AND 'SILVERFISH" to "FOR RESIDENTIAL USE TO CONTROL COCKROACHES, ANTS AND SILVERFISH"
- 5. Within the subsection entitled "FOOD HANDLING ESTABLISHMENTS" Revise the following statements as follows: 1 "Care should be taken to avoid depositing the product onto exposed surfaces or introducing the material into the air. Avoid contamination of food or food processing surfaces:—"Do not apply this product to exposed food or food contact surfaces. Do not apply dust into the air."
- 6. The Storage and Disposal section must be enclosed in a box and revised as follows:

STORAGE AND DISPOSAL

If empty: Do not reuse this container. Place in trash or offer for recycling if available. If partly filled: Call your local solid waste agency or [INSERT TOLL FREE # HERE]² for disposal instructions. Never place unused product down any indoor or outdoor drain.

^{2.} The authorities that manage household waste programs are designated in many different ways and usually operate only during normal business hours. The Agency's intent is that consumers have easy access to locally accurate disposal information, when they need it. Use Restrictions: Children and pets should not be in treatment area until after application is completed. Do not treat pets with this product. Avoid contamination of feed and foodstuff. Avoid contamination of ornamental plants.

Application Directions for Flea and Dust Mite Control: Apply to dry surfaces only. Apply directly on carpets where pets frequently traffic or sleep at the rate of one pound per 300 square feet. Work powder deep into fibers and mat with a broom or rug rake. Any powder visible after application must be brushed into carpet fibers or removed by vacuuming. Allow powder to remain for a period of three weeks to achieve maximum flea control in carpets. Reapply as necessary.

Additional Use Sites and Application Instructions: Remove loose cushions of upholstered furniture. Apply powder along creases and into corners and furniture wells. Do not apply product to exposed fabric. Work powder deep into wells and the surrounding hidden furniture fabric until it disappears. Apply powder lightly to all mattress, box spring, cushion and pillow surfaces that will be covered with sheets or like fabric after treatment. Any powder visible after application must be removed. Apply powder lightly to hardwood floor surfaces. Using a broom, completely work any visible powder into all cracks and crevices. Apply and brush in evenly 1 oz of product to each side of filters located in air returns of home heating/air conditioning systems. After applying to filters remove any non-adhering powder by gently tapping filter on edge against a hard surface. Remove any product that becomes dislodged by vacuuming.

DOMESTIC (HOMEOWNER USE) COCKROACHES, ANTS & SILVERFISH

Use Restrictions: Children and pets should not be in treatment area until after application is completed. Do not treat pets with this product. Avoid contamination of feed and foodstuff. Avoid contamination of ornamental plants.

Application Directions for Cockroaches, Ant and Silverfish Control: Apply in small amounts directly into cracks and crevices using a bulbous duster or other suitable equipment capable of

applying insecticides directly into cracks and crevices, in points between different elements of construction, between equipment and floors, openings leading to voids and hollow spaces in walls, equipment legs and bases, conduits, motor housing and electrical switch boxes where target insects hide. Apply liberally, scattering under and behind washing machine and dryer, tubs; into openings around drains, water pipes and electrical conduits; and in cracks and crevices along baseboards and corners of cabinets, cupboards, and closets. Remove all lower drawers in kitchen and bathroom cabinets, bedroom dressers and chests of drawers, and then scatter liberally in drawer wells. Any powder visible after application must be removed. Reapply as necessary.

NON-DOMESTIC USE (NONEDIBLE PRODUCT AREAS ONLY)

Use Restrictions: Children and pets should not be in treatment area until after application is complete. Do not use in edible product areas of food handling establishments, restaurants, or other areas where food is commercially prepared or processed. Do not use in serving areas while food is exposed.

Directions for Applying in New and Existing Construction to Control Cockroaches: When treating large areas, such as wall voids, soffit and sub-cabinet voids in new and existing construction, dust liberally using dusting application equipment.

Directions for Applying in Sewers and Manhole Cavities: Apply this product at a rate not to exceed 12 oz. per 190 sq. ft. using portable blowers or air pressure tanks.

Directions for Applying as a Mop Solution to Control Cockroaches:

Mixing and Application Directions: Add 1 cup of powder to each gallon of rinse water. Apply to floor areas only. Make only enough for each application, Supplemental treatment only. Re-apply as necessary. Any powder visible after application must be brushed into cracks and crevices or removed. Avoid contamination of feed and foodstuff.

FOOD HANDLING ESTABLISHMENTS

Places other than private residences in which food or feed is held, processed, prepared, or served is limited to CRACK AND CREVICE TREATMENT ONLY. Applications to other areas are not permitted.

Application Directions: Apply in small amounts directly into cracks and crevices using a bulbous duster or other suitable equipment capable of applying insecticides directly into cracks and crevices, in points between different elements of construction, openings leading to voids and hollow spaces in walls, where target insects hide. Care should be taken to avoid depositing the product onto exposed surfaces or introducing the material into the air. Avoid contamination of food or food processing surfaces.
