Dear Mr. McLane:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable provided that you:

- 1. Make the following changes to your label:
 - a) In the Directions for Use "FLEAS ON DOGS & CATS", delete the sentence "Do not treat kittens under 2 months old." The correct age is 12 weeks which appears earlier on your label.
 - b) In the Direction for Use "FLEAS ON DOGS & CATS", change the sentence "Repeat as needed" to "Repeat as needed, but not more than once a week."
 - c) In the Directions for Use on ASPARAGUS, delete the sentence "Do not apply more often than once every 3 days."
 - d) In the Directions for Use on BRUSSELS SPROUTS..., delete "5 to" from "treat every 5 to 7 days..."
 - e) In the Directions for Use on CORN, change "...treat corn silks every 3 days..." to "...treat corn silks every 7 days..."

- f) In the Directions for Use on LETTUCE, delete "5 to" from "...treat every 5 to 7 days.."
- g) In the Directions for Use on ORNAMENTALS, change the sentence "Repeat as needed for continued control" to "Repeat as needed for continued control, but not more than once a week."
- 2. Submit one copy of your final printed labeling before you release the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions.

A stamped copy of the labeling is enclosed for your records.



Dust lightly to cover both upper and lower leaf surfaces. In a thin even deposit of dust. Apply when air is calm to avoid drift and intact with eyes and skin. Start applying at the farthest corner of the treatment area and work backward to avoid contact with dusted surfaces. Allow dust to settle in treated areas before reentering. For plants above the chest height, consider using a liquid carbaryl product. Do not repeat application more than once a week.

FOR USE ON PETS use product only outside or in a well-ventilated area. Wearing household latex or rubber gloves, dust entire animal, avoiding pet's eyes, nose, mouth and genital areas. Rub or brush pet's hair to work dust down to the skin, This product should not be applied by children. Do not use on pregnant dogs. READ ENTIRE LABEL BEFORE USING

GREEN CHARM SEVIN 5% Brand Carbaryl insecticide DUST may be applied with any suitable dust applicator. For best results make application in the morning or evening when the air is still. Be sure to treat both upper and lower surfaces of leaves. Apply (down wind) to give thorough coverage but avoid applying in excess. Applications should be started when insects first appear. Repeat as necessary. Apply at 7 to 10 day intervals, or 3 to 5 day intervals in rainy weather. Listed below are the crops with the pests controlled followed by the time interval to stop applications prior to harvest. As a general rule apply enough dust to give thorough coverage to all plant parts or 11 to 15 ounces per 1,000 sq.ft. (equal to 30 to 40 lbs. dust per acre.)

TURF & PERIMETER INSECTS

Apply 8 oz, to cover 250 sq.ft. of turf or around building foundation area

Apply 8 oz, to cover 250 sq.ft. of turf or around building foundation area to control Earwigs - Millipedes - Sod Webworms - Leafhoppers and Ants. Area should be lightly sprinkled after application to wash dust off foliage. Repeat as necessary. Keep children and pets off treated areas until grass has been sprinkled and area is dry.

FLEAS ON DOGS & CATS

For control of Fleas, and Brown Dog Ticks, rub 1/2 to 1 level tablespoonful into pets skin. Also treat sleeping, loafing and other infested quarters. Replace with fresh bedding. Treat entire pet especially in area where insects are seen. Avoid getting into pets eyes. Groom the pet several hours after treatment. Do not treat kittens under 2 months old. Use lower rate and apply sparingly for cats. Repeat as needed. Do not use on pregnent doors. pregnant dogs.

VEGETABLES and FRUIT

ASPARAGUS: Asparagus Beetles. Do not apply later than 1 day before harvest. Do not apply more often than once every 3 days.

BEANS: Mexican Bean Beetle, Bean Leaf Beetle, Leafhoppers, Flea Beetles, Com Earworms, Lygus Bugs, Stink Bugs, Lima Bean Pod Borer, Japanese Beetle. Can be applied day of harvest.

BEETS (table): Armyworms, Flea Beetles, Leafhoppers, 3 days before harvest. 14 days before harvest if tops are used for food or feed.

BRUSSELS SPROUTS, BROCCOLI, CABBAGE, CAULI-FLOWER: Small Cabbage Looper, (treat every 5 to 7 days for control), Armyworms, Flea Beetles. Do not apply later than 3 days before harvest.

CARROTS: Leafhoppers, Flea Beetles. Can be applied day of harvest.

CITRUS: Black Scale, California Red Scale, Soft Brown Scale, Orange Tortrix, California Orange Dog, Fruit Tree Leaf Rollers. For Scale Insects best results are obtained when crawlers are present. Apply 5 days before harvest.

COLLARDS, KALE, MUSTARD GREENS, RADISHES

RUTABAGAS, CHINESE CABBAGE, HORSERADISH and TURNIPS: Flea Beetles, Harlequin Bug, Leafhoppers, Armyworm, Imported Cabbageworm, Tarnished Plant Bug and Stink Bugs, (3 days of harvest on horseradish, radishes, rutabagas and turnip roots; 14 days on Chinese cabbage, collards, kale, mustard greens and turnip tops).

CORN(Sweet): Corn Earworm, Flea Beetles, Leafhoppers, Fall Armyworms. For Corn Earworm control treat corn silks every 3 days until silks dry. Can apply day of harvest.

CUCUMBERS, MELONS, SQUASH, PUMPKINS, CANTA-LOUPES: Squash Bugs, Leafhoppers, Cucumber Beetles, Flea Beetles. Do not apply to Melons or Cucumbers when temperatures exceed 80° F or when vines are wet. Can be applied day of harvest.

EGGPLANT: Com Earworm, Flea Beetles, Homworms, Cucumber Beetles. Can be applied day of harvest.

LETTUCE: Armyworms, Small Cabbage Looper (treat every 5 to 7 days for control), Leafhoppers, Salt Marsh Caterpillars. For Head Lettuce; 3 days before harvest. Leaf Lettuce; 14 days before harvest.

PEPPERS: Com Earworm, Leafhoppers, Flea Beetles. Can be applied up to day of harvest.

POTATOES (White); Flea Beetles, Leafhoppers. Can apply day of harvest.

TOMATOES: Tomato Fruit Worm, Tomato Homworm, Flea Beetles, Stink Bug, Leafhoppers. Apply day of harvest.

STRAWBERRIES: Leaf Rollers, Lygus Bugs, Salt Marsh Caterpillar. One day before harvest
