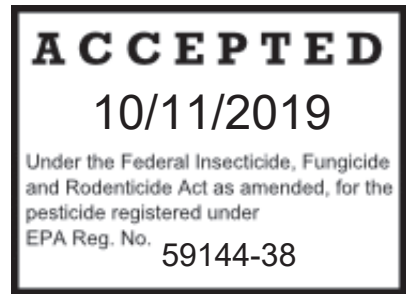

- Do not apply to excessively sunburned skin.
- Do not apply under clothing.
- Apply sparingly around ears.
