F-STOP is a biological fungicide seed dressing specifically for control of diseases caused by soil-borne <u>Pythium</u> spp. F-STOP should be used on seeds to be planted when soil temperatures exceed 50 degrees F. F-STOP may be applied as a water based slurry or in combination with diluents, carriers and/or adjuvants approved for use for coating seed through standard slurry or mist-type commercial seed treatment equipment. Avoid exposing F-STOP or seed treated with F-STOP to other fungicides.

DIRECTIONS FOR USE

SEED TREATMENT

Cotton

- Mechanical or flame delinted For <u>Pythium</u> spp. seedrot and damping-off, apply F-STOP as a seed treatment at the rate of 5 ounces active ingredient per 100 lbs. of seed.
- Acid delinted Before treatment, buff is seed to increase pH to 4.0. For <u>Pythium</u> spp. seedrot and damping-off, apply F-STOP as a seed treatment at the rate of 5 ounces active ingredient per 100 lbs. of seed.

Beans (green & dry), Cabbage, Corn (field & sweet), Cucumbers,

Peanuts, Potatoes, Sorghum, Soybeans, Sugar Beets and Tomatoes.

For control of Pythium spp. damping-off, apply F-STOP as a seed treatment at the rate of 5 ounces active ingredient per 100 lbs. of seed.

Treated seed must be discolored. Add a dye to the seed treatment mixture.

Note: The purchaser of this product is responsible for ensuring that all seed treated with this product are adequately dyed with a suitable color to prevent its accidental use as food for man or feed for animals. Refer to 21CFR, Part 2.25. Any dye added to treated seed must be cleared for use under 40 CFR, Part 180.1001.

SPECIAL INSTRUCTIONS

Apply F-STOP only in cleaned equipment completely free of fungicide residues. Seed treated with F-STOP should be stored cool and dry. Do not freeze or expose to temperatures above 80 degrees F. for prolonged periods.

STORAGE AND DISPOSAL

Pesticide Storage and Disposal

Store in a cool dry place. Do not freeze or expose to a temperature above 80 degrees F. for prolonged periods. Keep container tightly closed when not in use. Wastes resulting from use of this product may be disposed of on site or at an approved waste disposal facility.

Container Disposal

Completely empty contents of bag into seed treatment equipment. Dispose of empty bags in a sanitary landfill or by incineration, or by open burning, if allowed by state and local authorities. If burned, keep out of smoke.
