

IG MICRO DT is used in recirculating commercial and industrial water control systems. Systems must be cleaned to remove algal growth and other deposits. An initial slug addition of 6.9 IG MICRO DT per 1000 gallons is recommended. Repeat initial dosage until control is evident. Subsequent slug additions of 2.3 IG MICRO DT per 1000 gallons every 1 to 5 days, or as needed. The frequency and relative amount of bleedoff and the severity of the additions should be made in the sump of water control systems.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. **STORAGE:** Do not expose to extreme temperatures. Store in five drums high. Drums should be opened in well-ventilated areas. Damaged drums should be placed in overpack drums and disposed of in a container closed when not in use.
