INDUSTRIAL & COMERICAL RECIRCULATING COOLING WATER SYSTEMS

FORMULA 4635 should be applied directly to the cooling water at any section of the system where sufficient mixing will occur. Such as food, beverage, and industrial pasteurizers.
