2. As noted in the Agency letter dated May 12, 2010, the following studies remain outstanding and must be submitted to the Agency:
 - OPPTS 870.6200: Acute and Subchronic Neurotoxicity Studies
 - OPPTS 870.7800: Immunotoxicity Study
3. Per 40 CFR 156.10(6), submit one copy of your final printed labeling before you release the product for shipment. As defined in 40 CFR 152.3, "final printed labeling" means the "label or labeling of the product when distributed or sold." Clearly legible reproductions or photo reductions will be accepted for unusual labels. Note that a clean copy of the master label in most cases does not meet the definition of final printed labeling.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions. A stamped copy of the label is enclosed for your records.
