a. Correct the first sentence to read as follows: Do not apply this product in a manner that allows spray to drift and contact humans, animals or other nontarget sites.

b. Remove the last sentence of the paragraph and revise the second to the last sentence by removing the text "and grower".

c. Remove the listed examples of application methods ("e.g., ground, aerial, airblast, chemigation") as they are not the methods specified in the use directions for this product.

4. Correct the claims "cockroaches, ants, crickets, fleas, and firebrats" to "cockroaches, ants (excluding fire, harvester, carpenter and pharaoh), crickets, fleas and firebrats". Cockroaches, Ants, Crickets, Fleas and Firebrats: Apply as a coarse, low pressure spot spray, crack and crevice spray or with a paint brush to localized areas where these pests are found or normally occur including corners of rooms and closets; around television sets and radios; along and behind baseboards; around and under sinks, dishwashers, washing machines, refrigerators, stoves and cabinets; areas where plumbing enters or leaves the room; or other areas inhabited by these pests.

NOTE: A period of 3 to 7 days may be necessary for *Orthene* PCO Formula II to reach its maximum effect on cockroaches.
