Dear Mr. Schreier:

The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act as amended is acceptable provided the following change is made:

• STORAGE AND DISPOSAL - CONTAINER DISPOSAL: Change fourth sentence of the "CONTAINER DISPOSAL" instructions from "Dispose of liner in a sanitary landfill by incineration...." to "Dispose of liner in a sanitary landfill or by incineration...." Add the sentence "If burned, stay out of smoke." before "If drum is contaminated...."
