Dear Dr. Halarnkar:

The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act as amended is acceptable provided the following changes are made:

- 1. On page 3, change all the "To the fullest extent allowed by law" or variations, to "To the extent consistent with applicable law".
- 2. Move Disclaimer on page 3 to end of label.
- 3. On page 4, after (1), change the bold face to "FOR COMMERCIAL GREENHOUSE, LATHHOUSE, AND SHADEHOUSE USE (WHERE PLANTS ARE GROWN IN CONTAINERS) ONLY:"
- 4. On page 4, after fruiting vegetables, add "(eggplant, groundcherry, pepino, pepper, tomatillo, tomato)"
- 5. On page 5, change "Do not reuse container" to "Do not reuse liner (container)."
