

**Note to Physicians:** Emergency Information - call 1-800-892-0099. Acephate is a cholinesterase inhibitor. If signs of cholinesterase inhibition appear, atropine is antidotal. 2-PAM is also antidotal and may be used in conjunction with atropine but should not be used alone.
