The Agency has reviewed your submission for revised labeling and a revised Confidential Statement of Formula, and the following comments apply:

1) Regarding the proposed labeling:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable with the following provisions:

- a) Add the appropriate Net Contents statement.
- b) Add a Container Disposal statement to read "Triple rinse (or equivalent). Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or by incineration, or if allowed by state and local authorities, by burning. If burned, stay out of smoke."
- 2) Regarding the proposed Confidential Statement of Formula:

The Confidential Statement of Formula dated July 6, 1995 for the basic formulation agrees with the label claim in compliance with PR Notice 91-2 and is acceptable.
