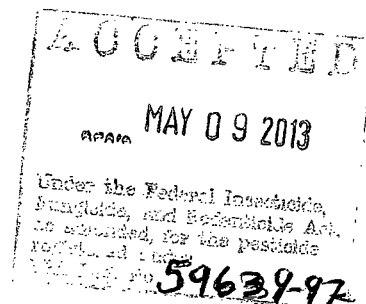
The supplemental labeling must be incorporated into the main product labeling within eighteen (18) months of the date of this letter.
