Your Submission Dated March 15 and June 28, 2004

The amendment referred to above, submitted in connection with registration under section 3(c)(7)(B) of the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), is acceptable provided that you:

1. Submit/cite all data required for registration/reregistration of your product under FIFRA section 3(c)(5) or 4(a) when the Agency requires all registrants of similar products to submit such data.
2. Make the following label changes listed below before you release the product for shipment:
 - a. On the Chateau WDG Herbicide Supplemental Labeling correct the EPA Registration No. To read "59639-119"
 - b. Add the heading "Drift Management" and the following spray drift language in the application directions:

Avoiding spray drift at the application site is the responsibility of the applicator and the grower. The interaction of many equipment and weather related factors determines the potential for spray drift. The applicator and grower must consider the interaction of equipment and weather related factors to ensure that the potential for drift to sensitive non-target plants is minimal.

This pesticide may only be applied when the potential for drift to adjacent sensitive areas (e.g, residential areas, bodies of water, non-target plants) is minimal (i.e., when the wind is blowing away from the sensitive area).

Note: when the Supplemental labeling is incorporated onto the Master Label the Drift Management statements need to appear only once in the General Information section.


c. On the Pome Fruit and Stone Fruit Supplemental Labeling clarify the directions for use by adding specific directions for use including application method, use rate, and weeds controlled. On the Strawberry supplemental label indicate the weeds controlled.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions.

A stamped copy of the label is enclosed for your records.

CHATEAU, at 3 oz. per acre, can be applied to the soil a minimum of 30 days prior to transplanting strawberries provided the strawberries will be transplanted through a plastic mulch.

CHATEAU, at 3 oz. per acre, can be applied to dormant strawberries for the preemergence control of the weeds listed in Table 1 of the CHATEAU container label.

CHATEAU, at 3 oz. per acre, can be applied with a shielded or hooded sprayer for the preemergence control of the weeds listed in Table 1 of the CHATEAU container label in strawberry row middles.

DIRECTIONS FOR USE IN POME AND STONE FRUIT

GENERAL RESTRICTIONS AND LIMITATIONS

- Do not apply more than 12 oz. of CHATEAU WDG per acre during a single application.
- Do not apply more than 24 oz. of CHATEAU WDG per acre during a single calendar year.
- Do not make a sequential application within 30 days of the first application.
- Do not apply within 60 days of harvest.
- Do not apply to pome or stone fruit trees established less than one year, unless protected from spray contact by non-porous wraps, grow tubes or waxed containers.
- Do not apply after petal fall unless using hooded or shielded application equipment and applicator can ensure spray drift will not come in contact with crop fruit or foliage.
- Follow the most restrictive label limitations and precautions of the tank mix product(s) being used.

CHATEAU WDG should be applied as a uniform band to the orchard floor. Avoid direct or indirect spray contact to foliage and green bark (non-barked trunk).
