Subject: Revised Labeling for Secure Miticide EPA Registration No. 59639-123 Submission Date: March 2, 2004

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable with the following provisions:

1) Since Secure Miticide, as a solid, describes application rates using a unit of measure of ounces, and since the recommended tank mix product for strawberries, Danitol 2.4 EC, is a liquid product, specify the unit of measure for Danitol 2.4 EC within the rate chart for strawberries as "fluid ounces".

2) The submitted apple and pear field trial data are adequate, but do not reflect the proposed use patterns. The submitted apple field trial data do not support concentrate spray volumes [20-100 gallons/acre (GPA)]. Therefore, the label should be amended to include the following: applications to pome fruit should be made in a minimum spray volume of 100 GPA.

3) Choose either season or growing season within the following sentences found within the pome fruit, strawberry, non-bearing fruit and nut trees, and Christmas trees tables: "Do not make more than 1 SECURE application per growing season." and "Do not apply more than 3.0 oz. SECURE per acre per season."
