GENERAL INFORMATION

Do not apply this product through any type of irrigation system. Not for use by homeowners.

S-1812 PPG-Overture 35 WP is a wettable powder insecticide containing 35 percent active ingredient pyridalyl for greenhouse use. S-1812 PPG Overture 35 WP provides control of thrips (including Western flower thrips) and the larvae of various lepidopteran insect pests infesting greenhouse grown ornamentals, including flowering and foliage crops, ground covers, shrubs and ornamental trees, and non-bearing fruit and nut trees grown indoors. S-1812 PPG Overture 35 WP may also be applied to greenhouse grown head and stem brassica (Subgroup 5A), fruiting vegetables (except cucurbits) (Crop group 8) and leafy vegetables (except brassica vegetables) (Crop group 4).
