On the basis of information furnished by the registrant, the above named pesticide is hereby registered/reregistered under the Federal Insecticide, Fungicide and Rodenticide Act.

Registration is in no way to be construed as an endorsement or recommendation of this product by the Agency. In order to protect health and the environment, the Administrator, on his motion, may at any time suspend or cancel the registration of a pesticide in accordance with the Act. The acceptance of any name in connection with the registration of a product under this Act is not to be construed as giving the registrant a right to exclusive use of the name or to its use if it has been covered by others.

This product is <u>conditionally</u> registered in accordance with FIFRA sec. 3(c)(7)(C), provided that:

- 1. You will submit and/or cite all data required for registration/reregistration of your product under FIFRA sec. 3(c)(5) when the Agency requires all registrants of similar products to submit such data; and submit acceptable responses required for reregistration of your product under FIFRA section 4.
- 2. You will make the following label changes before you release the product for shipment:
 - a) Revise the EPA Registration Number to read "EPA Reg. No. 59639-126."
 - b) Under Directions for Use
 - o Delete "Shadehouses". This product is only allowed for use in enclosed greenhouses.
 - ORevise "Indoor Non-residential"... to read "Enclosed Greenhouse Non-food use: on Ornamental plants (including: bedding plants, flowering plants, foliage plants, ground covers, trees and shrubs) and non-bearing fruit, nut and vine crops."
 - o Revise "Indoor food uses on..." to read "Enclosed Greenhouse Food uses on..."
 - o Revise "Brassica (cole) ..." to read "Head and Stem Brassica (sub group 5A)"
 - o List the commodities for each Crop group/Subgroup.
 - c) Revise the Precautionary Statements to read: "Prolonged or repeated skin contact may cause allergic reactions in some individuals. Wear long-sleeved shirt, long pants, socks, shoes, and gloves. Wash thoroughly with soap and water after handling."

- d) Since the product is in Toxicity Category IV for all routes of exposure, the Signal Word and First Aid statements are not required. You may delete these statements. Note that the Child Hazard Warning is still required.
- e) Delete the first paragraph under Environmental Hazards.
- f) Revise the Container Disposal statement so that it is consistent with PR Notice 2007-4.

If the data and discussions submitted belong to the TGAI/MUP produced on pilot plant scale, then data for the TGAI/MUP batches produced on commercial scale should be submitted when available. If there are significant variations, a new updated CSF must be submitted.
- 6. The product chemistry data submitted to support registration of this product are acceptable to fulfill the data requirements of 830 Series subgroup A and Subgroup B with the exception of data corresponding to guideline reference 830.7370 (dissociation constant). You must submit the data or request for a waiver in writing.
- 7. You will submit three (3) copies of your final printed labeling before releasing the product for shipment.

You should note that if you fail to satisfy any of the conditions imposed on this registration, e.g., you fail to submit the required data by the specified deadlines or the data submitted were not generated in accordance with applicable test guidelines, EPA may issue notice to cancel this registration under FIFRA 6(e).
