# Subject: Fluopicolide Technical; EPA Reg. No. 59639-139 Your Amendment Dated May 9, 2008 Linked with EPA Reg. No. 59639-140, Decision #373399

Dear Dr. Halarnkar,

The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act as amended to add new uses for brassica (head & stem), bulb vegetables, root vegetables (except carrot, potato, and sugar beets), and leaves of root and tuber vegetables, is acceptable, provided you submit the following:

1. Additional storage stability data are required by June 30, 2012 to support the *Brassica* head and stem, bulb, and root vegetable crop field trials. Storage stability studies with a representative root or tuber vegetable (reflecting analysis of roots and tops) and a *Brassica* vegetable must be conducted. The requested data for a root or tuber vegetable may be translated to bulb vegetables. The required studies must reflect the storage conditions of samples from the crop field trials and must include storage intervals of up to 47 months for the root or tuber vegetable in any representative commodity, additional storage stability data studies will normally be required on additional commodities of that group [see OPPTS 860.1380(c)(5)(ii)(D)].

One copy of the label stamped "Accepted" is enclosed for your records. This label supersedes all labels previously accepted for this product. Please submit one copy of the final printed label that incorporates the required changes before the product is released for shipment. 
