2. For the pyridinyl-¹⁴C-labeled cow metabolism study (MRID 46708518):

A. Storage stability data are required to support the study. If samples were stored for greater than 6 months, provide data showing stability of the metabolic profile of the affected matrices for the duration of the storage period and under the conditions that the samples were stored.

B. Clarify that the identification of two peaks in liver methanol/water extract retention times are correct, and explain how the retention times for these metabolites were correlated with the identified metabolites in urine and kidney.

C. Correct the flowchart for fat to include the correct total radioactive residue (TRR) value for this matrix (0.039 ppm).

D. Recalculate the radioactivity levels and/or clarify the results for the HPLC analysis of any extract in which the calculated limit of quantitation (LOQ) was too high to allow meaningful interpretation of the chromatogram.

3. For the hen metabolism study reported in MRID 46708515, provide complete sample history information for samples from the study, including not only dates of collection but also dates of storage, radioassay, extraction, and analysis. If sample analyses were not completed within 6 months of sample collection, provide data demonstrating that the metabolic profile was stable in the affected matrices during the storage period and under the conditions that the samples were stored. Also submit copies of the LC/MS chromatograms of metabolite AE C653711 (BAM) in liver as well as the corresponding chromatogram of the reference standard. These chromatograms were referenced in the submission (MRID 46708515, page 113) but were not included.

4. The hen metabolism study conducted with $[2,6^{-14}C$ -pyridinyl]fluopicolide (MRID 46708519) is incomplete but upgradeable. The samples from this study were not extracted until >6 months after sample collection. Provide data showing stability of the metabolic profile for the duration of the storage period and under the conditions that the samples were stored.

5. For storage stability data for crops, submit additional storage stability data for celery and spinach reflecting a storage interval of 38 months. One study should be conducted on any representative leafy vegetable.

6. Submit one copy of a final printed label within 45 days from the date of this Notice which makes the following changes:

A. On Page 2, change the dollar signs (\$) and large letter X's (X) used for bullets to another symbol(s).

B. On Page 5 under "Mode of Action", correct or clarify the disharmony between "The biochemical mode of action of fluopicolide is specific", vs just below this section "Both group 43 and 28...for which no specific mode of action is known". Deletion of the first sentence with "specific" or changing "mode of action to "site" may harmonize these contradictions.

C: On page 6; in the rainfastness section downy mildew is mentioned but is not a listed disease so the sentence must be modified to delete it.

D. On page 9, delete "interiorscapes" as that indoor use was not assessed.

E. In the ornamental section, add the following restriction or equivalent, "The reentry interval for hand harvesting, thinning, pruning, and pinching of ornamental flowers is 6 days after the last product application".

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA Section 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

GENERAL INFORMATION

V-10162 VPP fungicide is formulated as 5.7 lbs. ai/gal. suspendable concentrate (SC). The active ingredients in V-10162 VPP are fluopicolide and propamocarb hydrochloride. V-10162 VPP exhibits protective, curative, eradicative and antisporulant activity. Fluopicolide is locally systemic, translaminar and also moves systemically via xylem tissue.

Optimal disease control is achieved when V-10162 VPP is applied in a regularly scheduled spray program used in combination and/or rotation with other effective fungicides that have different modes of action (i.e., non group 28 & 43 fungicides).

MODE OF ACTION

V-10162 VPP is active against selective oomycetes. It exhibits the typical mode of action of specific systemic fungicides against oomycete fungi affecting several steps in the reproduction cycle.

The biochemical mode of action of fluopicolide is specific. Biochemical studies have shown that fluopicolide has an effect on spectrin-like proteins, believed to play a role in maintaining the membrane stability in ascomycete fungi or oomycetes, especially during hyphal tip extension. Microscopy studies demonstrate that fluopicolide induces a quick redistribution of these proteins from the membrane to the cytoplasm in both hyphae and zoospores.

Propamocarb is believed to effect lipids and membrane synthesis, resulting in altered cell membrane permeability.

RESISTANCE MANAGEMENT

- V-10162 VPP contains fluopicolide and propamocarb which are group 43 & 28 fungicides, respectively. The target site of action of Group 28 & 43 fungicides are specific but the biochemical modes of action are not known. Fungal isolates with acquired resistance to fluopicolide and propamocarb may eventually dominate the fungal population if V-10162 VPP is used repeatedly in the same use site or in successive years as the primary method of control for targeted species. - 3. Place cap on jar, invert 10 times, let stand for 15 minutes, evaluate.

 - a) Layer of oil or globules on the mixture's surface.
 - b) Flocculation: fine particles in suspension or as a layer on the bottom of the jar.
 - c) Clabbering: thickening texture (coagulated) like gelatin.

SPRAYER PREPARATION

Before applying V-10162 VPP, start with clean, well maintained application equipment. The spray tank, hoses and booms must be cleaned to ensure no residue from the previous spraying operation remains in the sprayer. The spray equipment must be cleaned according to the manufacturer's directions for the last product used before the equipment is used to apply V-10162 VPP. If two or more products were tank mixed prior to V-10162 VPP application, the most restrictive cleanup procedure should be followed.

MIXING INSTRUCTIONS

- 1. Fill clean spray tank 1/2 to 2/3 of desired level with clean water.
- 2. While agitating, slowly add the V-10162 VPP to the spray tank. Agitation should create a rippling or rolling action on the water surface.

The chemigation to turfgrass sites, apply this product only through center pivot, solid set, hand move or moving wheel irrigation systems. Apply V-10162 VPP in 1/2 to 3/4 inches of water during the first sprinkler set.

For chemigation to ornamental sites apply this product only through microirrigation (individual spaghetti tube), drip irrigation, overhead irrigation or motorized calibrated irrigation equipment.

The system must be properly calibrated (with water only) to ensure that the amount of V-10162 VPP applied corresponds to the recommended rate.

Allow time for all lines to flush the fungicide through all nozzles before turning off irrigation water. To ensure the lines are flushed and free of remaining fungicide, a dye indicator may be injected into the lines to mark the end of the application period.

If you have any questions about calibration, you should contact your State Extension Service Specialist, equipment manufacturers or other experts.

Special Precautions for Chemigation

- 1. Do not connect an irrigation system (including greenhouse systems) used for pesticide application to a public water system unless the pesticide label-prescribed safety devices for public water systems are in place.
- 2. A person knowledgeable of the chemigation system and responsible for its operation or under the supervision of the responsible person, shall shut the system down and make necessary adjustments should the need arise.
- 3. The system must be free of leaks and clogged nozzles.
- 4. The pesticide must be supplied continuously for the duration of the aqueous application. An uneven application may cause injury to the crop or poor control.
- 5. Agitation must be maintained in the nurse tank.
- 6. The sprinkler chemigation system must contain a functional check valve, vacuum relief valve and low pressure drain appropriately located on the irrigation pipeline to prevent water source contamination from backflow.
- 7. The pesticide injection pipeline must contain a functional, automatic, quick closing check valve to prevent the flow of fluid back toward the injection pump.
- 8. The pesticide injection pipeline must contain a functional, normally closed, solenoid operated valve located on the intake side of the injection pump and connected to the system interlock to prevent fluid from being withdrawn from the supply tank when the irrigation system is either automatically or manually shut down.
- 9. The system must contain functional interlocking controls to automatically shut off the pesticide injection pump when the water pump motor stops, or in the case where there is no water pump, when the water pressure decreases to the point where pesticide distribution is adversely affected.
- 10. The irrigation line or water pump must include a functional pressure switch which will stop the water pump motor when the water pressure decreases to the point where pesticide distribution is adversely affected.
- 11. Systems must use a metering pump, such as a positive displacement injection pump (e.g., diaphragm pump), effectively designed and constructed of materials that are compatible with the pesticides and capable of being fitted with a system interlock.
- 12. Do not apply when wind speed favors drift beyond the area intended for treatment.

Chemigation Systems Connected to Public Water Systems

- 1. Public water system means a system for the provision to the public of piped water for human consumption, if such a system has at least 15 service connections or regularly serves an average of at least 25 individuals daily at least 60 days out of the year.
- 2. Chemigation systems connected to the public water system must contain a functional, reduced pressure zone (RPZ), backflow preventer or the functional equivalent in the water supply line upstream from the point of pesticide introduction. As an option to the RPZ, the water from the public water system should be discharged into a reservoir tank prior to pesticide introduction. There shall be a complete physical break (air gap) between the outlet end of the fill pipe and the top overflow rim of the reservoir tank of at least twice the inside diameter of the fill pipe.
- 3. All chemigation systems connected to the public water system must also follow restrictions listed in the preceding section titled "Special Precautions for Chemigation".

TURFGRASS

V-10162 VPP is effective at preventing and controlling damping off, root rot and stem diseases caused by pythium blight infesting turfgrass. Pythium blight is sometimes referred to as greasy spot or cottony blight and is in a group of fungi known as water molds. This disease is common in turfgrass areas with poor soil drainage and a wet turfgrass canopy. High humidity and high temperatures provide an ideal environment for development of pythium blight. Pythium blight occurs in all cool season grasses, but is especially prevalent in creeping bentgrass, annual bluegrass and perennial ryegrass.

ORNAMENTAL PLANTS

V-10162 VPP is effective at preventing water mold, root rot, stem rot, crown rot and damping off caused by pythium and phytophthora diseases in ornamental plants. V-10162 VPP is mixed with water and applied as a soil drench at the time of seeding or transplanting. V-10162 VPP may be used on container, bench, or bed-grown ornamentals in greenhouses or outdoor nurseries, interiorscapes, conifers including Christmas trees and for use on ornamentals grown for outdoor landscaping.

IMPORTANT: The large number of existing ornamental species and their varieties and cultivars coupled with the constant introduction of new varieties makes it impossible to field test V-10162 VPP in every locale where it is sold or in all of the combinations of location and plant variety. Further differences include the soil or media type, pH, moisture or fertility, environmental conditions such as temperature, lighting or degree-days and horticultural practice and the manner of use and application of this product. To ensure that V-10162 VPP is compatible with the ornamental plant variety or cultivar under your specific conditions, test this product on a limited scale and observe for phytotoxicity or other unintended effects for two weeks before making large scale applications.
