## PRODUCT INFORMATION

**V-10524 FS** (containing ethaboxam, fludioxonil, inpyrfluxam and mefenoxam) is a fungicide seed treatment product offering both contact and systemic activity in providing broad-spectrum protection against seed and seedling diseases. The fungicides in **V-10524 FS** are effective for protection against soilborne *Pythium* spp., *Phytophthora sojae*, *Rhizoctonia solani* and *Fusarium* spp. as well as seedborne pathogens including [*Ascochyta* spp.], [*Botrytis cinerea*], *Phomopsis* spp., *Fusarium* spp., *Penicillium* spp., *Cladosporium* spp., *Alternaria* spp., [ *Aspergillus* spp.] [and] [*Colletotrichum* spp].

## MODE OF ACTION

Ethaboxam belongs to the thiazole carboxamide class of chemistry which inhibits cell division. Fludioxonil belongs to the phenylpyrrole class of chemistry which inhibits osmotic signal transduction. Inpyrfluxam is a succinate dehydrogenase inhibitor (SDHI) and belongs to the carboxamide class of chemistry which disrupts cellular respiration and energy generation. Mefenoxam belongs to the phenylamide class of chemistry which interferes with fungal RNA synthesis.



## RESISTANCE MANAGEMENT

For resistance management, please note that **V-10524 FS** contains **Group 22**/ethaboxam, **Group 12**/fludioxonil, **Group 7**/inpyrfluxam, and **Group 4**/mefenoxam fungicides. Any fungal population may contain individuals naturally resistant to **V-10524 FS** and other **Group 22**, **Group 12**, **Group 7**, or **Group 4** fungicides. A gradual or total loss of pest control may occur over time if these fungicides are used repeatedly in the same fields. Appropriate resistance-management strategies are to be followed.

To delay fungicide resistance, take one or more of the following steps:

- Rotate the use of **V-10524 FS** or other **Group 22**, **Group 12**, **Group 7**, or **Group 4** fungicides with different groups that control the same pathogens.
- Use tank mixtures with fungicides from a different group that are equally effective on the target pest when such use is permitted. Use at least the minimum application rate as labeled by the manufacturer.
- Adopt an integrated disease management program for fungicide use that includes scouting, uses historical information related to pesticide use, and crop rotation, and which considers host plant resistance, impact of environmental conditions on disease development, disease thresholds, as well as cultural, biological and other chemical control practices.

## APPLICATION DIRECTIONS

Accurate application of **V-10524 FS** to seed is required for best performance. Thoroughly mix **V-10524 FS** in the desired seed slurry mixture, prior to application to seed. Pre-test tank mixtures with other seed treatment products to evaluate formulation compatibility and to ensure proper physical compatibility of products. **DO NOT** tank mix with any products which contain a prohibition on tank mixing.

It is the pesticide user's responsibility to ensure that all products are registered for the intended use. Read and follow the applicable restrictions and limitations and directions for use on all product labels involved in tank mixing. Users must follow the most restrictive directions for use and precautionary statements of each product in the tank mixture.

## SEED QUALITY AND STORAGE OF TREATED SEED

Seed treatments applied to low vigor or poor quality seed or to mechanically damaged seed may result in loss of seed germination or reduced seedling vigor. ## SEED BAG TAG REQUIREMENTS

The Federal Seed Act requires that bags containing treated seed be labeled or tagged with the following information:

- This seed has been treated with **V-10524 FS** (EPA Reg. No. 59639-ETU) containing ethaboxam, fludioxonil, inpyrfluxam and mefenoxam.

Regardless of the method of application, the maximum yearly total application rate for ethaboxam is 0.0251 lb ai/A, 0.875 lb ai/A for fludioxonil, 0.131 lb ai/A for inpyrfluxam, and 0.052 lb ai/A for mefenoxam or metalaxyl- containing products.
- **DO NOT** apply more than the maximum application rate allowed for legume vegetables (except soybean) per acre per year. Regardless of the application method, the maximum yearly total application for ethaboxam is 0.062 lb ai/A, 0.0085 lb ai/A for fludioxonil, 0.020 lb ai/A for inpyrfluxam, and 0.25 lb ai/A for mefenoxam or metalaxyl- containing products.
- Store treated seed away from feeds and other foodstuffs.

## STORAGE AND DISPOSAL
