- 3. The following changes are necessary due to the Agency's definitive language policy.
  - On page 2, delete the word "General" from the "General Information" header and from "... General Precautions" sub-header.
  - On page 2 under the section "Insect Resistance, remove the word "recommended" in the last sentence of the paragraph. This section contains mandatory statements, and the prime header "General Information" may mislead users to believe that all the information that follows in the subheaders are advisory, instead of mandatory.
  - Page 3 under the section entitled "Application Through Irrigation Systems (Chemigation)", replace the word "recommended" with the word "specified"
  - Also on page 3 replace the word "should" with the word "must" in paragraph two of the "Safety Devices for Irrigation Systems Connected to Public Water Supplies" section.
  - On page 4 under "Mixing Instructions" remove the word "Recommended" from Drench and Irrigation Applications on line 2 of the paragraph.
  - Also on page 4 under the **Tank Mix** section replace the word "**should**" with the word "**must**" or reword the statement in such a way that it is clearly definitive language.
  - On page 5 replace "should" with "must" in the section bullet under the section entitled Use Precautions.

- 4. Also on pages 5, 6, 7, 8, and 9 make the following changes to each of the tables:
  - Remove the word "Recommended" from "Recommended Applications" and replace "Recommended Rate" with "Application Rate".
  - On page 6, under "Food Crops", revise the second sentence as follows: "A 12 month plant back interval **must** be observed..."
  - On page 7 in column 3 last paragraph replace the word "should" with the word must" or reword the statement using definitive language.
  - On page 8, in the third column of the table, reword the grid system sentence as follows: "Space holes on 2.5 ft centers...tree."
- 5. Revise the Confidential Statement of Formula (CSF) with the updated source EPA Reg. No. and new product number.
- 6. Submit two copies of your final printed label before you release the product for shipment. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product constitute acceptance of these conditions.

# **ENVIRONMENTAL HAZARDS**

# **GENERAL INFORMATION**

Marathon 60 WP will control insects on ornamental and vegetable plants grown in nurseries, greenhouses and interior plantscapes. Marathon 60 WP is a systemic insecticide applied as a soil treatment *only* and is translocated upward within the plant. For best results, Marathon 60 WP must be applied where the roots of the target plants can absorb the active ingredient. After application, irrigate moderately but thoroughly being sure to avoid leaching and runoff from the container for at least three irrigations or 10 days whichever is longer.

#### Marathon 60 WP General Precautions:

- A foliar application of any chloronicotinyl insecticide for resistance management purposes following Marathon 60 WP soil
  application in the same crop is NOT recommended.
- Do NOT use Marathon 60 WP packets in tank mix with products that contain boron or release free chlorine: the PVA packet reacts with boron or free chlorine to produce a plastic that is not soluble in water. NOTE: Normal chlorinated water is acceptable for mixing.

Insect Resistance: Some insects are known to develop resistance to insecticides after repeated use. As with any insecticide, the use of this product should conform to resistance management strategies established for the use area. Consult your Cooperative Extension Service for resistance management strategies and recommended pest management practices for your area.

**Incorporation:** Applications of Marathon 60 WP may be incorporated by cultivation, irrigation, rainfall, mechanical placement, soil injection, drenching and broadcast sprays.

Woody Perennials: Protection in woody perennials is slower than in herbaceous species and a delay of 2 or more weeks should be expected, with longer delays for larger plants. Because of this, applications to woody perennials should be made well in advance of expected insect activity.

Bark Media: Marathon 60 WP treatments to media with 30 - 50% or more bark content may confer a shorter period of protection.

# **DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in any manner inconsistent with its labeling.

Read entire label before using this product.

Do not apply this product in a way that will contact workers or other persons, either directly or through drift. Only protected handlers may be in the area during application. For any requirements specific to your State or Tribe, consult the agency responsible for pesticide regulation.

# AGRICULTURAL USE REQUIREMENTS

Use this product only in accordance with its labeling and with the Worker Protection Standard, 40 CFR part 170. This Standard contains requirements for the protection of agricultural workers on farms, forests, nurseries, and greenhouses, and handlers of agricultural pesticides. It contains requirements for training, decontamination, notification, and emergency assistance. It also contains specific instructions and exceptions pertaining to the statements on this label about personal protective equipment (PPE) and restricted-entry interval. The requirements in this box only apply to uses of this product that are covered by the Worker Protection Standard.

Do not enter or allow worker entry into treated areas during the restricted entry interval (REI) of 12 hours.

Exception: If the product is soil-injected or soil-incorporated, the Worker Protection Standard, under certain circumstances, allows workers to enter the treated area if there will be no contact with anything that has been treated.

# APPLICATION THROUGH IRRIGATION SYSTEMS (CHEMIGATION)

Marathon 60 WP may be applied at rates recommended on this label either alone or in tank mixture with other pesticides and chemicals registered for application through irrigation systems. The normal dilution ratio is 1:10 to 1:200, depending on the system. Always meter the product into the irrigation water during the first part of the irrigation cycle. The product may be mixed separately prior to injection. Agitation may be necessary if the mixture is allowed to stand more than 24 hours.

- Do NOT connect an irrigation system (including greenhouse systems) used for pesticide application to a public water system unless the pesticide label-prescribed safety devices for public water systems are in place.
- Apply Marathon 60 WP only through micro-irrigation (individual spaghetti tube), drip irrigation, overhead irrigation, and
  ebb and flood or hand-held or motorized calibrated irrigation equipment. Do not apply this product through any other
  type of irrigation system. Crop injury or lack of effectiveness can result from non-uniform distribution or treated water.
- Be sure to remove scale, pesticide residue and other foreign matter from the tank and entire irrigation system prior to application.
- A person knowledgeable of the chemigation system and responsible for its operation, or a person who is under the supervision of the responsible person, shall shut the system down and make necessary adjustments should the need arise.
- If you have any questions about calibration, you should contact State Extension Service specialists, equipment
  manufacturers or other experts.

# SAFETY DEVICES FOR IRRIGATION SYSTEMS CONNECTED TO PUBLIC WATER SUPPLIES:

If the source of water for your irrigation system is a public water supply, follow the instructions below:

- 1. Public water system means a system for the provision to the public of piped water for human consumption if such system has at least 15 service connections or regularly serves an average of at least 25 individuals daily at least 60 days out of the year.
- 2. Chemigation systems connected to public water systems must contain a functional, reduced-pressure zone, backflow preventer (RPZ) or the functional equivalent in the water supply line upstream from the point of pesticide introduction. As an option to the RPZ, water from the public water system should be discharged into a reservoir tank prior to pesticide introduction. There shall be a complete physical break (air gap) between the outlet end of the fill pipe and the top or overflow rim of the reservoir tank of at least twice the inside diameter of the fill pipe.
- 3. The pesticide injection pipeline must contain a functional, automatic, quick-closing check valve to prevent the flow of fluid back toward the injection pump.
- 4. The pesticide injection pipeline must contain a functional, normally closed, solenoid-operated valve located on the intake side of the injection pump and connected to the system interlock to prevent fluid from being withdrawn from the supply tank when the irrigation system is either automatically or manually shut down.

- 5. The system must contain functional jocking controls to automatically shut off the jsticide injection pump when the water pump motor stops, or in cases where were is no water pump, when the water pressure jecreases to the point where pesticide distribution is adversely affected.
- 6. Systems must use a metering pump, such as a positive displacement injection pump (e.g. diaphragm pump) effectively designed and constructed of materials that are compatible with pesticides and capable of being fitted with a system interlock.
- 7. Do not apply when wind speed favors drift beyond the area intended for treatment.

#### SAFETY DEVICES FOR IRRIGATION SYSTEMS NOT CONNECTED TO A PUBLIC WATER SUPPLY:

- 1. The system must contain a functional check valve, vacuum relief valve and low-pressure drain appropriately located on the irrigation pipeline to prevent water source contamination from backflow.
- 2. The pesticide injection pipeline must contain a functional, automatic, quick-closing check valve to prevent the flow of fluid back toward the injection pump.
- 3. The pesticide injection pipeline must also contain a functional normally closed solenoid-operated valve located on the intake side of the injection pump and connected to the system interlock to prevent fluid from being withdrawn from the supply tank when the irrigation system is either automatically or manually shut down.
- The system must contain functional interlocking controls to automatically shut off the pesticide injection pump when the water pump motor stops.
- 5. The irrigation line or water pump must include a functional pressure witch which will stop the water pump motor when the water pressure decreases to the point where the pesticide distribution is adversely affected.
- 6. Systems must use a metering pump such as a positive displacement injection pump (e.g. diaphragm pump) effectively designed and constructed of materials that are compatible with pesticides and capable of being fitted with a system interlock.
- 7. Do not apply when wind speed favors drift beyond the area intended for treatment.

#### **MIXING NSTRUCTIONS**

Within each foil pouch is a clear, water-soluble inner packet containing Marathon 60 WP. To prepare the mixture, remove the outer foil pouch and drop the required number of unopened clear water soluble packets, as determined under "Recommended Drench and Irrigation Applications", into the spray tank while filling the water to the desired level. Operate the agitator while mixing. Depending on the amount of agitation and the water temperature, the packets should be completely dissolved within a few minutes of being added to the water, with cooler water temperatures increasing the time needed for the inner packet to dissolve completely.

# **Mixing Precautions:**

- Do NOT allow packets to become wet prior to adding to the tank.
- Do NOT handle the clean inner packets with wet hands or wet gloves.
- Rough handling of the packets may cause breakage.
- Reseal outer carton to protect remaining packets.

**Tank Mixes:** Marathon 60 WP has been found to be compatible with commonly used liquid fertilizers, fungicides and insecticides. Marathon 60 WP is not known to be compatible with your particular tank mix partners, compatibility should be checked using the correct proportion of products in a small jar test.

#### **APPLICATION TO GRASSY AREAS IN NURSERIES**

#### NOTE: Marathon 60 WP may NOT be used on commercial sod farms.

Marathon 60 WP will control soil-inhabiting pests in grassy areas in or around nurseries such as under or around field or container grown plants, on roadways or other grassy areas. The need for an application can be based on historical monitoring of the site, previous records or experiences, current season adult trapping or other methods. Applications may be made preceding the egg laying activity of the target pests and high levels of control may be achieved when applications are made preceding or during the egg laying period. For best results, make applications prior to egg hatch of the target pests, followed by sufficient irrigation or rainfall to move the active ingredient through the thatch.

Japanese beetle (Popillia japonica)

Oriental beetle (Anomala orientalis)

Black turfgrass ataenius (Ataenius spretulus and Aphodius spp.)

Northern and Southern masked chafers (Cyclocephala borealis, C. immaculate, and/or C. lurida)

## **Use Precautions:**

- Applications must NOT exceed a total or 10.7 oz (0.4 lb of active ingredient) per acre per year.
- Applications should NOT be made when grassy areas are waterlogged or the soil is saturated with water because adequate
  distribution of the active ingredient cannot be achieved when these conditions exist.
- The treated grassy area must be in such a condition that the rainfall or irrigation will penetrate vertically in the soil profile.

# **Application Instructions:**

Apply Marathon 60 WP in sufficient water to provide adequate distribution in the treated area. The use of accurately calibrated equipment normally used for soil application of insecticides is required. Use equipment that will produce uniform, coarse droplet spray, using a low pressure setting to eliminate off-target drift. Check calibration periodically to ensure that equipment is working properly.

## **IRRIGATION AND DRENCH APPLICATIONS**

Marathon 60 WP may be applied to ornamental and vegetable plants in greenhouses, nurseries and interior plantscapes using soil drenches, micro-irrigation, overhead irrigation, ebb and flood irrigation, or hand-held or motorized calibrated irrigation equipment.

#### **Use Precautions:**

- Do not graze treated areas or use clippings from treated areas for feed or forage.
- Do not apply to soils that are water logged or saturated, which will not allow the penetration of the insecticide into the root zone of the plants.
- Do not allow leachate runout for the first 10 days after application, in order to retain the product and facilitate full plant uptake of the active ingredient.
- For outdoor ornamentals grown in beds or turf, applications of Marathon 60 WP cannot exceed a total of 10.7 oz (0.4 lb of active ingredient) per acre per year.
- On plants with a production cycle of less than one year, application is not to exceed a frequency of more than once each 16 weeks for a particular plant. On stock plants and woody crops with a production cycle of greater than one year, application may not exceed once a year.

#### Food Crops:

Treated areas may be replanted with any crop specified on an imidacloprid label, or with any crop for which tolerance exists for the active ingredient.

A 12-month plant-back interval should be observed for crops not listed on an imidacloprid label or for crops for which no tolerances for the active ingredient have been established.
