The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below. Three (3) copies of the finished labeling must be submitted prior to releasing the product for shipment. A stamped copy of the product label is enclosed for your records.

1. Regarding the accompanying brochure: the following claims are not acceptable for the reasons provided.

- a. "The miticidal effect of ACAROSAN may last up to 8 months." This label claim must be substantiated.
- b. "ACAROSAN has been toxicologically and dermatologically tested." This statement is an implied safety claim. Refer to 40 CFR 156.10(a)(5).
- c. "ACAROSAN is free of agents which might irritate your respiratory tract." This statement is an implied safety claim. Refer to 40 CFR 156.10(a)(5).
- d. "ACAROSAN has a long-lasting effect (up to 6-8 months)." The phrase "ACAROSAN has a long-lasting effect" is acceptable. However, the claim "(up to 6-8 months)" must be substantiated.

2. Reinstate the statement "Keep children and pets off carpet during treatment and until area is vacuumed" into the PRECAUTIONARY STATEMENTS text in the product brochure.

The Confidential Statement of Formula dated March 9, 1994, and received March 15, 1994 is acceptable and has been included in the record for this pesticide product.
