What You Should Know About House Dust Mites:

House dust mites are natural inhabitants of our surrounding environment. The presence of house dust mites does not indicate a lack of cleanliness. House dust mites do not pose a problem for most people, but they certainly do for people who are allergic to them. House dust mites avoid contact with humans and are not known to transfer any diseases that we know. They are not visible to the naked eye.

They live in house dust and feed on its various particles, especially on the flakes from human or animal skin contained in the dust. The average human loses up to 1.5 grams of skin particles per day. This amount is sufficient for the nourishment of house dust mites and even tides them over during periods in which the rooms are not entered. In addition, they consume material of other origin, such as pieces of fiber, feathers, etc.

The development and propagation of house dust mites is dependent upon relative humidity and temperature. They thrive at temperatures between 20° and 30°C (68° and 84°F) and a relative humidity of 65-80%. This moderate, moist climate is prevalent in many parts of the United States from May to October. This is also the period in which house dust mites mature and breed. Relative humidity over 90% and below 33% is harmful to them. For this reason house dust mites are rarely found in high mountain areas (that is, higher than 3600 feet above sea level) because the relative humidity is too low.

Relative humidity is more important than temperature for house dust mites living, growing and propagating conditions.

House dust mites are often found in mattresses, upholstery, rugs, carpets, quilts, pillows and almost all textile items (including children's textile toys). Sleeping areas of house pets are also favorite spots.

House Dust Mite Allergy Caused By Mite Excrements

House dust mite allergy is not only caused by the house dust mites themselves, but also by their excrement (feces). What makes matters worse, the excrement and the allergens contained therein are present all year long - as opposed to pollen allergens which induce allergic reactions only during periods of pollen. Constant exposure to house dust mite allergens can lead to chronic (long term) illnesses.

Due to the dry air during heating periods, dead dried mite body and body parts can become airborne. Further, the finely grained excrement breaks down to an extremely fine powder. This powder sticks to the surrounding materials, such as the fiber structure in carpets and upholstery and may become airborne. This happens when the carpet or rug is

walked upon, when sitting down or rising from upholstery, and when shaking out blankets and airing out rooms.

The house dust mite problem can be solved only by first destroying the house dust mites. The excrement and mite bodies can then gradually be removed by repeated cleaning procedures.

How ACAROSAN® Moist Powder Works

ACAROSAN® Moist Powder is a preparation designed to destroy the house dust mites in your room. The development of this product has been preceded by years of research on the living habits, growth and propagation of house dust mites.

ACAROSAN® Moist Powder consists of four main components:

The House Dust Mite Destroying Component consists of benzyl benzoate combined with mineral substrate.

The Dust Removing Component

Isoparaffin and water release the dust and dirt particles (therefore the allergen containing excrements) from the base of the carpet.

The Binding Component

When applied, the powdery base is initially compounded with water. As soon as the water has evaporated, the powdery base binds the dust particles which have been broken down by the isoparaffin and water. This creates larger particles which do not become airborne and are removable by vacuuming.

The Water Base

The mucous membranes in the respiratory system of persons allergic to house dust mites are especially sensitive. Therefore, it is important that preparations be free of agents (such as irritating vapors or gases) which could irritate the respiratory tract. For this reason, ACAROSAN® Moist Powder has a water base.

Duration Of Effect

Within a few hours of the initial ACAROSAN treatment, the house dust mites stop moving. Within the first day they are dead. House dust mites which are not reached by the first treatment eat the pulverized ACAROSAN residue while working their way through the fibers. This also kills house dust mite larvae which are just hatching out of their eggs. The miticidal effect of ACAROSAN is long-lasting.

How To Use ACAROSAN® Moist Powder

 Start with one room. It is not necessary to treat your entire home or several rooms at one time. Persons with an oversensitive respiratory tract should not apply ACAROSAN themselves.

Use only on colorfast carpets. Check for colorfastness in an inconspicuous area first.

2. Shake the ACAROSAN* Moist Powder onto the carpeting or rugs (work section by section) and distribute evenly with a broom or scrubber. Brush the Moist Powder firmly into

the fibers. One bag will suffice for approximately 120 sq. ft.

- 3. Let the items treated with the powder dry for 3-12 hours. After the powder has dried, vacuum thoroughly. The allergic patient should not vacuum. Vacuum bags should be replaced often because you must remove the quantity of powder applied. Use up contents of opened ACAROSAN⁸ Moist Powder bags immediately.
- 4. For best results, ACAROSAN should be applied after 3 months and thereafter every 6-8 months or when you acquire new carpets or rugs to prevent infestation.
