
The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, Rodenticide Act, is acceptable subject to the comment listed below:

**DIRECTIONS FOR USE**

It is a Violation of Federal Law to use this Product in a Manner Inconsistent with its Labeling.

**INDOORS:** For use in Horse Barns, Dairy Barns, Milking Parlors, Milk Handling Areas of Milk Plants, Hog Barns, Kennels, Zoos and Farm structures housing Animals and Poultry.

**DILUTE:** Py-Tech 1.5% + 15% Concentrate Prior to use as follows:

0.10% Pyrethrins - Add 1 part concentrate to 15 parts water.

0.05% Pyrethrins - Add 1 part concentrate to 30 parts water.

**DILUTE:** Py-Tech 1.5% + 15% Concentrate Prior to use as follows:

**ANIMAL TREATMENT:** To kill and repel house flies, horn flies, face flies, deer flies, stable flies and horse flies on dairy and beef cattle, horses, hogs, sheep and goats. Apply the 0.1% dilution as a coarse particle spray or sponge at the rate of 2 ounces per large animal on a daily basis. Avoid spraying in eyes. Repeat as necessary.
