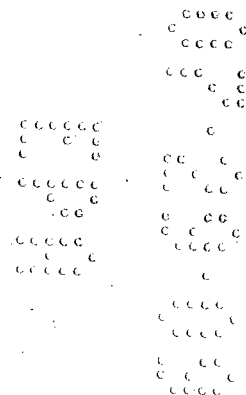

INSECTIGONE® CRAWLING INSECT KILLER is made from a patented formula containing amorphous diatomaceous earth, known as silicon dioxide, and selected baits. Insects come into contact with the powder or ingest it and literally dry up and die within 48 hours. INSECTIGONE® CRAWLING INSECT KILLER is an odorless, non-staining powder that remains effective in the control of insects as long as it is present and kept dry.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

DIRECTIONS: Unscrew cap and remove protective liner before using. ~~Remove cap and cut tip above the top line with scissors or knife.~~

INDOOR USE: COCKROACHES, ANTS, EARWIGS, SILVERFISH, CRICKETS, MILLIPEDES, AND CENTIPEDES. Lift open spout to desired setting and lightly coat a thin layer of dust in the areas where these pests are found or may hide such as cracks and crevices, behind and beneath stoves, refrigerators, sinks, cabinets, garbage cans, around pipes and drains, window frames, and in attics and basements. Hit insects directly where possible. Repeat treatment as necessary.

FLEAS: Thoroughly dust floor area of pet's sleeping quarters, as well as surrounding cracks, crevices, baseboards, behind pictures and wherever presence of these insects is suspected.

CARPET BEETLES: Thoroughly dust along baseboards, edges of carpeting, under furniture, under carpeting and rugs and in closets and shelving or wherever these insects are seen or suspected.

BEDBUGS: Take bed apart. Dust into joints and channels. If hollow, such as square or round tubing, see that the interior of the framework is well dusted. Mattresses should be dusted, especially tufts, folds and edges. Picture frame molding and all cracks and crevices in the room should be treated.
