It is a violation of Federal Law to use this product in a manner inconsistent with its labeling. **Product Description:** This product is a top-of-the-line hard modified epoxy antifouling paint for use on boat bottoms. It is an antifoulant protective coating resistant to algae, barnacles and other marine fouling. Designed to repel fouling in the most severe fouling tropical waters, it can be used equally successfully in temperate waters as well as fresh water. This product may be applied on fiberglass, wood or properly primed steel boats. It is ideal for both power and sail boats, anywhere a durable finish and long lasting performance is desired.

Surface Preparation: The surface to be painted should be dry, dean and free of any contaminants. It should be properly prepared by solvent cleaning and sanding before any primers or paints are applied. Follow the recommended systems below. When sanding old antifouling paint, always use a face mask to prevent the inhalation of sanding dust. Application and Temperature: This product may be applied by brush, roller or spray at any temperature between 40°F and 90°F. Do not apply this product if rain or dew is expected before the surface has dried completely. Two coats should be applied for best antifouling protection.

Preparation of Paint: This product is heavily loaded with cuprous oxide. As a result of this loading there is a tendency for setting to occur especially if the paint has been on the shelf for several months. It is necessary to thoroughly mix the paint before using. If possible shake the can of paint on a mechanical paint shaker. Before using check the sides and bottom of the can to make sure all the pigment has been mixed in. If mixing is going to be done with a wooden paddle or an electric drill mixer, pour off half of the logid from the top of the can into another can and then properly mix in any settled pigment; then remix the two parts together thoroughly.

Previously Painted Surfaces: If the previous coating is in good condition, thoroughly sand with 80 grit paper then solvent clean with 120 Brushing Thinner to remove residue. Apply two finish coats of this product. If the previous coating is soft or in poor condition, remove to the bare surface by sanding or using a paint & varnish remover. Proceed with appropriate bare system as described below. Old tin copolymers should be removed or sealed with Petit 6627 Tie Coat Primer before applying this product.

Bare Fiberglass: All bare fiberglass, regardless of age, should be thoroughly cleaned several times with petitit 95 Dewaxer or 120 Brushing Thinner. Sand thoroughly with age get sandpaper to a point frosty finish and relevant the sanded surface with 95 Fiberglass Dewaxer or 120 Brushing Thinner to remove-signifing-residult. This apply two coals of this product, following application instructions. Careful observation of the above instructions will help ensure long term adhesion of this and subsequent years' antiforuing paint.
